2 QUOTATION REQUIREMENTS

Quotations are hereby requested for the provision of services for the development of prototype for Desktop Computer Numeric Control (CNC) Machine. The services required include:

- Industrial design of the Desktop CNC machine
- Machining of parts for the new prototype
- Produce 3D computer modelling of all component based on required specifications
- Develop manufacturing drawing based on the specification
- Develop assembling and manufacturing process for the CNC machine
- Technical illustrations for product manuals
- Package design
- Graphic design for product-related documents and brochures

4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

5 OTHER TERMS AND CONDITIONS

- 5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives.
