# 1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply of a fixed-line managed bandwidth fibre link of 10Gbps capacity between the South African Astronomical Observatory (SAAO), Southern African Large Telescope (SALT) site in Sutherland and the South African National Research Network (SANReN) Point of Presence (PoP) at Teraco data centre in Cape Town. The required route is one that is diverse to the current SANReN network link between these two sites, for a period of one (1) year, as specified in this RFQ for the South African National Research Network (SANReN).

#### 2 QUOTATION REQUIREMENTS

- 2.1 All quotations must be submitted to: <a href="mailto:tender@csir.co.za">tender@csir.co.za</a> with RFQ No.5992/30/01/2023 as the subject.
- 2.2 The tenderer should indicate an estimated time of delivery of the service from the time the official order is placed.
- 2.3 The quotation should be inclusive of delivery to: CSIR Main Campus, Building 43, Meiring Naude Ave, Brummeria, Pretoria, 0184.


# 2.4 Link Requirements

# NB: By responding to this RFQ, bidders are committing to the following technical requirements:

The link must be:

1. **Diverse** to existing SANReN network link between the following two sites and as show in the table and diagram below:

Suppliers must not offer any existing routes already provided to SANReN as a solution as this will not provide diversity. This solution will be eliminated from consideration.

- 2. Committed link capacity rate must be 10Gbps.
- 3. The link must be provisioned on fixed-line fibre infrastructure using existing infrastructure.
- 4. The link must terminate on active equipment at the sites specified.
- 5. All equipment deployed at the specified sites must be AC powered (220V 50Hz).
- 6. All equipment used must have their dimension requirement specified.
- 7. The link must support Link Loss Forwarding.
- 8. The link must support Jumbo Frames.
- 9. The link must be an Ethernet handoff on a 10GBASE-LR PHY interface.
- 10. The client hand-off must terminate on a patch panel.
- 11. The route is required for a period of one (1) year.

# 2.5 Reliability

# 2.5.1 Service Requirements

The CSIR requires that a minimum end-to-end up-time of 98% (calculated per quarter) to be maintained for this circuit that is part of this RFQ. To manage these requirements, the CSIR encourages all bidders to include a standard SLA (Service Level Agreement) as part of its response. By responding to this RFQ, bidders are committing, as a minimum, to comply to the following criteria to qualify to bid:

- 1. 24/7 access to a Network Operations Centre (NOC) to log support requests;
- 2. Maximum response time of 4 hours during office hours;
- 3. Maximum service restoration time of 8 hours during office hours; and
- 4. Quarterly end-to-end up-time reports for each circuit that is part of this RFQ.

#### 2.5.2 Maintenance

All bidders are committing to maintaining this link in accordance to the above specifications amongst others. When requested bidders must be able to provide the following information (or show they have the support capabilities) to do the maintenance works as follows:

- 1. Be able to specificity Mean Time To Repair.
- 2. Same day response, Working day response only, etc;
- 3. Fault Logging Procedures;
- 4. Maintenance down time procedures and advance warning procedures;
- 5. Fault Monitoring and Alerting capability;
- 6. Scheduled reporting of incidents & performance measurements; and
- 7. Customer responsibilities indicated;

The bidder may specify whether the link being provided in this tender will be actively monitored or not. If the link is actively monitored, the bidder to provide the CSIR, or a CSIR designated party, regular notifications on the status of the link and other specific details when requested.

# 2.5.3 Project Plan

The link must be delivered within 20 business days from the date the PO issued. CSIR has the right to cancel the PO if the winning bidder fails to deliver within the stipulated time frame.

# 2.5.4 Acceptance Documentation

In accepting this link, the CSIR will require:

- 1. Test results for the link
- 2. Acceptance test certificate documentation.

#### 3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the **80/20** preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <a href="www.csd.gov.za">www.csd.gov.za</a> to register. Neither a purchase order will be issued, nor will a contract be signed without a valid CSD number.
- 3.3 Provide valid copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
  - A valid sworn affidavit made on a DTI designed template; or
  - A DTI issued sworn affidavit; or
  - CIPC issued B-BBEE certificate.
- 3.4 No B-BBEE status will equal zero points during the evaluation. Neither a purchase order will be issued, nor will a contract be signed without a valid B-BBEE Certificate.

#### 4 ELIMINATION CRITERIA

- 4.1 If the solution provided is not diverse to the existing SANReN route, the solution will be eliminated.
- 4.2 Quotations received after the closing date will not be considered.
- 4.3 Quotations received at an incorrect location or email address will not be considered.

- 4.4 Submissions received by tenderers who do not submit a signed Declaration by Tenderer form, will not be considered.
- 4.5 Quotations will not be considered if the tenderer is on the National Treasury list of restricted suppliers.
- 4.6 Quotations will not be considered if the tenderer is on the National Treasury list of Defaulters.
- 4.7 Tenderers that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.
- 4.8 Bidders must have the ECNS and ECS licences as required by Law.

#### 5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT) or (incl. VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.
- 5.4 Clearly indicate VAT charged where applicable (if not VAT registered, please state so clearly).

#### 6 OTHER TERMS AND CONDITIONS

- 6.1 The tenderer shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
