## **SECTION A – TECHNICAL INFORMATION**

## 1 INTRODUCTION

The Council for Scientific and Industrial Research (CSIR) is one of the leading scientific research and technology development organisations in Africa. In partnership with national and international research and technology institutions, CSIR undertakes directed and multidisciplinary research and technology innovation that contributes to the improvement of the quality of life of South Africans. The CSIR's main site is in Pretoria while it is represented in other provinces of South Africa through regional offices. This Expression of Interest (EOI) is published to establish a pool of suitable, pre-qualified suppliers to supply support services is the categories as stipulated below on an "as and when required" basis for a period of three (3) years.

## 2 BACKGROUND

The Defence & Security Cluster of the CSIR conducts multi-disciplinary research and development on various defence and security topics for the benefit of various organs of state and industry. The Cluster has extensive, capital-intensive test and evaluation facilities as well as a deep skills base in various fields of science and technology including but not limited to Aeronautics Systems, Command & Control, Information & Cyber Security, Landward Sciences, Optronic Sensor Systems as well as Radar & Electronic Warfare. The Cluster undertakes various activities that cover basic research, applied research, test and evaluation, technology development, technology localisation, technology commercialisation and custom solution development for a variety of applications. The Landward Sciences Impact Area has a requirement for land vehicle engineering services to develop vehicle concept demonstrators and prototypes.

## 3 INVITATION FOR EXPRESSION OF INTEREST

Expression of interest are therefore invited from suitable service providers for support services in the following categories:

3.1 Inspection, repair, custom design, and conversion of ISO shipping containers in accordance with relevant national and international

- standards, both onsite and remote locations, that maintain the containers certification and functionality for shipping and transportation.
- 3.2 Painting of equipment and containers (Shipping) in accordance with RSA-MIL-SPEC 42 Issue 4 or later, UN and / or relevant national and / or international standards that meets shipping container certification requirements. Preparation and painting must be done on site as well as at remote locations within in the RSA.
- 3.3 Painting of light and heavy vehicles (B and D type) in accordance with paint suppliers recommendations as a minimum or equivalent industry specification. Light and heavy vehicles must be painted on site and at remote locations within the RSA.
- 3.4 Material cutting services: This will include the cutting of materials with laser, plasma, water jet cutting according to drawings and withing specifications.
- 3.5 Welding support services: Welding (TIG, MIG) of components and complex designs with range of standard and specialised materials and thicknesses at CSIR premises and remote sites. Coded welding is a prerequisite. Services are to include preparation, execution, and inspection of welds.
- 3.6 Automotive mechanic services and repairs for military, standard and modified commercial vehicles to be executed onsite or at remote locations within the RSA. The work is to be executed in accordance with Original Equipment Manufacturer (OEM) manuals, methods and parts as needed. These repairs will include work on light B type vehicles, heavy D type vehicles as well as construction and industrial vehicles (e.g., tractors and forklifts).
- 3.7 Auto electrician services for inspection, service, repair and new installations includes the design, assembly, test and verification, inspection, servicing and repairs of auto electrical nature to be executed onsite or remote locations within the RSA. Work to be executed in accordance with required specifications. These repairs will include work

- on light B type vehicles, heavy D type vehicles as well as construction and industrial vehicles (e.g., tractors and forklifts).
- 3.8 Hydraulic system design, manufacturing, installation, certification, inspection, repairs, and servicing of military vehicle mounted systems. Services are to be executed onsite or at remote locations within the RSA in accordance with required specifications.

Note: All equipment and materials for execution of tasks a, b, e, f and g are to be supplied by the service provider executing the task. Materials for task c and d are contract specific.

## 4 EXPRESSION OF INTEREST REQUIREMENTS AND PROCESS

Service providers are to indicate interest in one or several of the categories indicated in Section 3 of this EOI. Evaluation criteria and scoring applicable to each of these categories is provided in Section 6. Submissions to this EOI will be evaluated against the respondents' indicated category(ies) of interest as per the criteria in Section 6, so that the CSIR can establish a prequalified pool of service providers per category listed in Section 3.

If all the compulsory criteria are met with respect to the category of interest in Section 6, including the supply of all necessary documentary proof, the CSIR reserves the right to undertake an onsite assessment before a service provider is added to the pre-qualified pool of service providers/suppliers associated with this EOI. Any onsite assessment will be co-ordinated appropriately with the service provider/supplier.

The CSIR will inform all applicants that successfully meet the pre-qualification criteria in due course. These applicants will be included in the pre-qualified pool (database) of service providers/suppliers associated with this expression of interest.

Once the pre-qualified database of service providers/suppliers is established for the various categories in Section 3, they will be approached for quotations on specific requirements on an "as and when required" basis.

The necessary documentation (which may include specifications, requirements, design packs, acceptance criteria, timelines and other critical information required) will only be provided by the

CSIR per each unique requirement, so that the relevant pre-qualified service providers/suppliers are able to develop quotations/proposals for consideration by the CSIR. Subsequently, the CSIR may consider awarding work (via a contract or purchase order) to pre-qualified service providers/suppliers whose proposal is determined to be the most advantageous to the CSIR, taking into consideration the technical (functional) solution, price and B-BBEE

## 5 PANEL ENGAGEMENT MODEL

Pre-qualified suppliers will be approached for quotations on specific services on an "as and when required" basis. The specifics for each request will be indicated on the Request for Quotation (RFQ) documents, and these will include but not limited to, the supplier's capability to meet the required delivery timelines, required quantities, and quality insurance.

## **6 TECHNICAL EVALUATION CRITERIA**

The evaluation of the functional / technical detail of the proposal will be based on the following criteria:

- Responses not submitted to <u>tender@csir.co.za</u>;
- Responses submitted after closing date and time;
- Companies listed on the National Treasury database of restricted suppliers;
- ISO 9001 or similar quality system certification.

## 9 PROCEDURE FOR SUBMISSION OF PROPOSALS

- All expression of interests must be submitted electronically to: <u>tender@csir.co.za</u>
   Respondents must use the EOI number as the subject reference number when submitting the bids
- The email and file sizes should not exceed a total of **25mb** on one email. If more than 25mb, more than one (1) email must be sent.

- All documents submitted electronically via email must be clearly visible.
- Tenders or documents received after the closing date and time will be considered as a late submission. Late submissions will not be evaluated.

#### 10 EOI PROGRAMME

The EOI program, as currently envisaged, incorporates the following key dates:

Last date for submission queries: 25 February 2022

Closing / submission date:
 1 March 2022

The CSIR will inform all successful suppliers qualifying to be registered on the panel of prequalified suppliers.

## 11 SUBMISSION OF RESPONSES

- 11.1 All EOI proposals are to be submitted electronically to tender@csir.co.za. No late proposals will be accepted.
- 11.2 All EOI proposals email submissions are to be clearly subject-referenced with the EOI number.
- 11.3 Responses submitted by companies must be signed by a person or persons duly authorised.

## 12 DEADLINE FOR SUBMISSION

Expression of interest shall be submitted at the address mentioned above no later than the closing date of, 1 March 2022 before 16h30.

Where an EOI is not received by the CSIR by the due date and stipulated place, it will be regarded as a late EOI. Late EOI's will not be considered.

## 13 EVALUATION PROCESS

The EOI evaluation process will only include functionality/technical evaluation. No price and B-BBEE evaluation will be done at this stage. To be appointed as part of the panel, the service provider must meet the minimum threshold for functionality.

## 14 VALIDITY PERIOD OF THE RESPONSES

Each proposal shall be valid for a minimum period of four (4) months calculated from the closing date.

## 15 ENQUIRIES AND CONTACT WITH THE CSIR

Any enquiry regarding this EOI shall be submitted in writing to CSIR at tender@csir.co.za with "EOI No 8054/1/03/2022: Vehicle related and general support services for Research and Development Purposes" as the subject.

Any other contact with CSIR personnel involved in this expression of interest is not permitted during the EOI process other than as required through existing service arrangements or as requested by the CSIR as part of the EOI process.

## 16 MEDIUM OF COMMUNICATION

All documentation submitted in response to this Expression of Interest must be in English.

Companies are expected to fully acquaint themselves with the conditions, requirements and specifications of this EOI before submitting responses. The CSIR is not responsible directly or indirectly for any costs incurred by Companies.

The service provider must confirm satisfaction regarding the correctness and validity of their EOI.
