## Request for Proposal (RFP) for the provision of Engineering, Construction, Installation and Commissioning Services of the Model Hall Facility situated at CSIR Stellenbosch Campus

On Friday, 19 April 2024, the Council for Scientific and Industrial Research (CSIR) invited bidders to submit proposals for the above-mentioned RFP.

The CSIR appreciates your interest in responding to the Request for Proposal.

Please note the following additions and changes in the advertised tender document:

- Correction of CIDB class of work from 6GB or 6ME or higher, to 6GB or higher.
- Inclusion of subcontracting arrangement: In the case of subcontracting arrangements, bidder must subcontract CIDB Contractor with **3ME** or **higher**, and submit a copy of the signed subcontracting agreement.
- Inclusion of the following paragraph on CONSTRUCTION INDUSTRY DEVELOPMENT BOARD (CIDB) as paragraph 31 under section B:
  - 31.1 Only those tenderers who are registered with the CIDB or are capable of being so prior to the evaluation of submissions, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a 6GB or higher class of construction work, are eligible to have their tenders evaluated.

- 31.2 Joint ventures are eligible to submit proposals provided that:
  - Every member of the joint venture is registered with the CIDB;
  - The lead partner has a contractor grading designation in the **6GB** or **higher** class of construction work; or not lower than one level below the required grading designation in the class of works construction works under considerations and possess the required recognition status.
  - The combined contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a 6GB or higher class of construction work or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations
- Amendment of elimination criteria "Bidder did not submit proof of public liability insurance of minimum R10 million" to Bidder who did not submit a valid proof of public liability insurance of minimum R10 million or letter of intension issued by insurer. In a case of letter of intension, bidder must provide a valid proof of public liability insurance of minimum R10 million with seven(7) days upon request.
- Second Compulsory Site Inspection date and time to be held on Thursday, 23 May 2024 at 12H00 to 13H00.
  - I. Venue: Building 2C CSIR Stellenbosch Campus
  - II. Note: Bidders who attended the first Compulsory Site Inspection do not need to attend the Second Compulsory Site Inspection date.
- The closing date has been moved to Friday, 31 May 2024 at 16:30.

All other terms of the RFP document remain unchanged.
