RE: NOTICE OF RELEASE OF ENVIRONMENTAL AUTHORISATIONS AND APPEAL PROCEDURE: PROPOSED DEVELOPMENT OF NINE 175 MW (9 X 175 MW) SOLAR PHOTOVOLTAIC (PV) FACILITIES AND ASSOCIATED ELECTRICAL GRID INFRASTRUCTURE, NEAR TOUWS RIVER IN THE WESTERN CAPE PROVINCE

As a registered Interested and Affected Party (I&AP) on the project database, you have been informed that the Project Developer, Veroniva (Pty) Ltd, is proposing the development of nine 175 MW (9 X 175 MW) Solar Photovoltaic (PV) power generation facilities and associated infrastructure, north-east of Ceres and north of Touws River, in the Witzenberg Local Municipality, Western Cape Province. Each solar PV facility will consist of associated infrastructure including various structures, buildings and Electrical Grid Infrastructure (EGI) such as, but not limited to, a 132 kV power line, an on-site substation and a Lithium Ion Battery Energy Storage System. The proposed nine Solar PV facilities will connect to the national grid at the existing Eskom Kappa Substation. The proposed Solar PV facilities and associated infrastructure will be constructed on the following farm portions: Grootfontein RE/149; Grootfontein 5/149; Witte Wall RE/171; and Hoek Doornen 1/172. The power lines will traverse these aforementioned farm portions, as well as Die Brak 241 and Platfontein 240. The details of each project are indicated in the table below:

As previously noted, the Project Developer appointed the Council for Scientific and Industrial Research (CSIR) to undertake the Environmental Assessment Processes required for the abovementioned proposed projects. The proposed projects were assessed in terms of the 2014 National Environmental Management Act (Act 107 of 1998, as amended) (NEMA) Environmental Impact Assessment (EIA) Regulations promulgated on 8 December 2014 and as amended on 7 April 2017 in Government

Notice (GN) R326, R327, R325 and R324. The proposed Solar PV projects and associated infrastructure are located entirely within the Komsberg Renewable Energy Development Zone (REDZ 2) (as gazetted in GN 114; 16 February 2018). Therefore, the proposed projects have been subjected to a Basic Assessment (BA) process, with a reduced decision making period of 57 days. Approval was granted by the Competent Authority, the National Department of Environment, Forestry and Fisheries (DEFF), now operating as the Department of Forestry, Fisheries and the Environment (DFFE) to submit combined Applications for Environmental Authorisation (EA) in terms of Regulation 11 (4) of the 2014 NEMA EIA Regulations (as amended), and the issuing of multiple EAs in terms of Regulation 25 (1) and (2) of the 2014 NEMA EIA Regulations (as amended). Therefore, four separate BA Reports were compiled (as indicated in the table above), which were made available to all I&APs, Organs of State and stakeholders for a 30-day review period extending from 3 December 2020 to 25 January 2021. The Final BA Reports were submitted to the DFFE, on 24 February 2021, for decision-making in terms of Regulations 19 (1) (a) and Regulation 20 of the 2014 NEMA EIA Regulations (as amended).

As a registered I&AP on the projects, in terms of Regulation 4 (2) of the 2014 NEMA EIA Regulations (as amended), you are hereby notified that the DFFE has granted EAs, for the abovementioned proposed projects. **Nine** separate EAs have been issued i.e. one for each solar PV Facility and associated infrastructure, as well as **nine** separate EAs for the power lines and associated EGI that are required to support the nine solar PV Facilities. The EAs are dated 26 April 2021. The reasons for the decision are detailed in Annexure 1 of the EAs, and for ease of reference have been extracted and separately attached to this correspondence.

Your attention is drawn to Chapter 2 of the National Appeal Regulations published in GN R993 on 8 December 2014, and as amended in GN R205 on 12 March 2015, which prescribes the appeal procedure to be followed. These regulations have been attached to this correspondence. Should you wish to appeal any aspect of the decision, an appeal must be submitted to the Appeal Administrator by the Appellant, and a copy thereof must be submitted to the Applicant, any registered I&AP and any Organ of State that has interest in the matter, within 20 days from the date that the notification of the decision was sent to the registered I&APs by the Applicant. Based on the above, you are hereby informed that the appeal period extends from 28 April 2021 to 19 May 2021.
