SECTION A – TECHNICAL INFORMATION

1 INTRODUCTION

The Council for Scientific and Industrial Research (CSIR) is a leading scientific research and technology development organisation in Africa. In partnership with national and international partners, CSIR undertakes directed and multidisciplinary research and technology innovation that contribute to the improvement of the quality of life of South Africans and the world at large. The CSIR's main site is in Pretoria while it is represented in other provinces of South Africa through regional offices.

The Defence & Security Cluster (DSC) of the CSIR conducts multi-disciplinary research and development (R&D) on various defence and security topics for the benefit of various organs of state and industry. The Cluster has extensive, capital-intensive test and evaluation facilities as well as a deep skills base in various fields of science and technology including but not limited to Aeronautics Systems, Command & Control, Information & Cyber Security, Landward Sciences, Optronic Sensor Systems as well as Radar & Electronic Warfare. The Cluster undertakes various activities that cover basic research, applied research, test and evaluation, technology development, technology localisation, technology commercialisation and custom solution development for a variety of applications.

The Landward Sciences Impact Area has been requested by the SA Army to investigate and identify PT dress samples for test and evaluation (T&E) purposes. This project will include the investigation and identification of PT dress suppliers that can provide locally manufactured commercial-off-the-shelf (COTS) items to meet the requirements of the SA Army to address the current constraints.

The request for information details the background and main requirements to allow prospective suppliers to provide CSIR with a brief on their respective products.

2 BACKGROUND

The CSIR is currently assisting the SA Army with the research, investigation and support to improve the physical training (PT) dress. The SA Army physical training dress is an integral part of the SA Army's Combat Dress Uniform System. The PT dress is used during training to ensure that soldiers can maintain an acceptable level of fitness as required. The current PT kits do not provide the support and performance required by the modern SA Army, hence the need for an upgrade.

3 REQUEST FOR INFORMATION

Interested parties should provide details of the following PT dress garments suitable for the modern SA Army soldier:

- Tracksuit jackets
- Tracksuit pants
- Short sleeve t-shirts
- Men's running shorts
- Men's swimming shorts
- Men's tights
- Women's running shorts
- Women's one-piece swimsuit
- Women's tights
- Women's sport bra
- Socks
- Training shoes
- Men's vests

4 RFI SPECIFICATIONS

The PT dress garments shall provide the following as a minimum:

- Adherence to current climatic conditions
- Breathability and flexibility
- Conformance to current physique of the modern soldier
- Swimwear shall conform to current swimming requirements
- Conform to modern size grading
- Use lighter materials to streamline soldier performance
- Shoes shall have modern soles to eliminate regular feet and shin problems for wearers during PT sessions
- Shoes shall provide thermal regulation and sweat-absorbing functionalities
- Shoes shall have long shelf life for storage purposes

8 DEADLINE FOR SUBMISSION

9 REVIEW PROCESS

Review of RFI submissions

All submissions will be reviewed by a review team.

10 BUDGETARY PRICING PROPOSAL

Respondents are requested to provide budgetary pricing by completing the Pricing plan breakdown (Annexure 1 in a XLSX format) for the procurement of the offered PT Dress.

11 LOCAL CONTENT

- 11.1** Only locally manufactured designated goods and/or services from local raw material or input will be considered.
- 11.2** If the raw material or input to be used for a specific item is not available locally, bidders should obtain written authorisation from the dtic should there be a need to import such raw material or input and;
- 11.3** A copy of the authorisation letter must be submitted together with the bid document at the closing date and time of the EOI. For further information, bidders may contact the dtic at telephone 012 394 3717/1390.
- 11.4** The guidelines and declarations that should be used by tenderers when preparing a tender are available on the dtic website. Guidance on the calculation of local content and manufacturing can be assessed on the dtic's official website:

- 11.5** Tenderers must complete Declarations D and E, and consolidate the information on Declaration C. Annexures C must be submitted with the tender by the closing date and time.
- 11.6** The Declaration Certificate for Local Production and Content (SBD 6.2) in addition to the above declarations must also be completed, duly signed and submitted by the bidder at the closing date and time of the tender; and

- 11.7** The rates of exchange quoted by the bidder in paragraph 6.8 below of the declaration certificate will be verified for accuracy.
- 11.8** The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) AT 12:00 on the date of advertisement of bid.
- 11.9** Only the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 must be used to calculate local content.
- 11.10** Bidders must clearly indicate in their bids, the quantities of products to be supplied, and the level of local content for each product.
- 11.11** Applicable local production and content minimum thresholds for this tender are as per the table below:
