# 1 INVITATION FOR QUOTATION

Quotations are hereby invited for the provision of a study on Marine Geology and Geophysics at the Port of Ngqura.

# 2 QUOTATION REQUIREMENTS

The service provider is required to quote based on the following scope and deliverables:

#### Project deliverables / costing:

- a) Mobilisation and Demobilisation of Equipment and Personnel to the Port of Ngqura. (Lump sum)
- b) Four (4) days Marine Geophysical and Hydrographic survey, on land geology.
- c) Report and Charts.

#### Project conditions.

- a) All costs door to door.
- b) Personnel cost to include Subsistence and Travel allowance.
- c) CSIR will provide all travel arrangements and equipment transport from Cape Town to the Port of Ngqura and return.
- d) CSIR will supply the survey vessel, navigation and positioning.
- e) CSIR will supply accommodation (Single Room)

f) Reports and charts to include side scan mosaic, interpreted seafloor facies, isopatch map, on-land geological map and colour coded bathymetric chart.

# 4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

# 5 OTHER TERMS AND CONDITIONS

- 5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
