## **1 INVITATION FOR QUOTATION**

The CSIR requires the services of a professional quantity surveyor to provide quantity surveying services for the renovation of existing offices in building 3 the CSIR Scientia Campus in Pretoria

## **2 QUOTATION REQUIREMENTS**

Quotations are hereby invited from Quantity Surveyors firms with a proven track record. The services are required immediately from date of appointment.

The project must make optimal use of limited funds to renovate the reception area and bathrooms in line with CSIR standards and branding.

The scope of work includes carrying out essential maintenance and repair works only. The activities include:

The activities include:

**Maintenance and repairs to the offices and boardrooms**

- Painting: Painting of the passages and offices
- Electrical reticulation/power skirting upgrade in line with safety requirements
- Repairs/replacement of inefficient air-conditioning on offices
- Blinds/curtaining: Replace all curtains with blinds in all offices

**Establish a reception area on the ground floor foyer**

- Reception counter with modern lighting
- New tiling to match CSIR design standards
- Painting
- Decorative wall paper in the foyer area: Modern wallpaper will be supplied and applied to the walls
- Directional signage: Directional signage to be updated in the entrance area near the lift.

The project construction budget to be used is estimated at R2 million excluding Fees and VAT. The estimated amount will be adjusted based on the final design.

The QS Fees must be based on gazetted tariff of fees.

A Standard CSIR contract will be signed as a form of agreement.

**3 ELIMINATION CRITERIA**

Bidders will be eliminated if they fail to provide the following information;

- At least a minimum of 3 contactable references for previous work done (bidders must provide telephone numbers and email addresses).
- A certificate for proof of professional registration.
- Provide Company Profile
- Provide an Indemnity insurance of R 2 million or more.
- Provide confirmation in writing their availability to work after hours should there be a need.
- Provide examples of 3 previous projects worth R2 million or more.

- Confirm in writing their availability to work after hours should there be a need.

#### **4 EVALUATION CRITERIA**

- 4.1 Suppliers that are eliminated on the basis of the elimination criteria set above, will not be evaluated on price and B-BBEE.
- 4.2 Selection of suppliers will be based on the 80/20 preference point system.
- 4.3 Submit a valid B-BBEE status with the quotation. No B-BBEE status will equal zero points.
- 4.4 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use [www.csd.gov.za](http://www.csd.gov.za) to register.
- 4.5 No order will be issued or no contract will be signed without a valid CSD number.
