1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply of cement powder ribbon blender to the CSIR Ekandustria Green Cements Piloting Site

2 QUOTATION REQUIREMENTS

The CSIR green cements piloting plant requires a cement powder ribbon blender which will be used to mix 2 or more cementitious dry powders at a time.

2.1 PRODUCT/SERVICE REQUIREMENTS:

An itemized quotation indicating the prices of

- (i) Ribbon blender including delivery,
- (ii) Installation and 2 years warranty and
- (iii) Servicing and after care costs for 5 years

2.2 TECHNICAL SPECIFICATIONS:

Ribbon mixer:

The blending mechanism should seek to blend (homogenize) powered cementitious materials and cement extenders.

Operational requirements of the ribbon blender

- Receive powdered cementitious materials from screw conveyor (design required)
- Blending capacity > 7.5 Tons/hour
- Discharge blended cement in to screw conveyor (design required)
- Powered by electricity.

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.3 No order will be issued or no contract will be signed without a valid CSD number.
 - Provide valid certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
 - Valid sworn affidavits made on DTIC designed templates; or
 - DTIC issued affidavit; or
 - CIPC issued B-BBEE certificate.

4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT) or (Inc VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

- 6 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
