

# The provision of services for the identification of benthic macrofauna in inshore sediment samples for the CSIR

#### 1 INVITATION FOR QUOTATION

Quotations are invited from experienced marine invertebrate taxonomists for the identification of benthic macrofauna in sediment samples collected in inshore coastal environments in South Africa for the CSIR, for a period of five (5) years. The services will be procured on an if required basis and are not guaranteed.

#### 2 QUOTATION REQUIREMENTS

- Quote for analysis of benthic macrofauna in sediment samples collected primarily from the inshore coastal environment of South Africa, including estuaries.
- The benthic macrofauna will already have been sorted from sediment and preserved.
- Responders are to provide the cost for one sample, noting there will usually be multiple samples for analysis at any time and if services are procured the one sample cost will be used to determine the total cost by multiplication.
- Results of analyses, comprising counts of each identified taxon in discrete samples, are to be
  provided in electronic format (Excel spreadsheet). A template will be provided by CSIR. This
  must be included in the cost.
- A reference collection of specimens identified must be provided to CSIR as a means of checking quality.
- Benthic macrofauna samples are to be returned to the CSIR. The CSIR will arrange for the transport of samples and responders do not need to include costs in this regard.
- Probable turnaround time for the analysis per sample must be provided.
- Responders must have prior experience (minimum 10 years). Experience must be
  demonstrated in supporting documentation and should outline training, degrees, and project
  experience of relevance. Responders should note that the CSIR may test the experience of
  responders by requesting they identify benthic macrofauna in pre-selected samples already
  processed by CSIR and other taxonomic experts.

#### 3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Proof of prior experience must be included in the evaluation.
- 3.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <a href="www.csd.gov.za">www.csd.gov.za</a> to register.
- 3.4 No order will be issued, and no contract will be signed without a valid CSD number.
- 3.5 Provide valid original or certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
  - Valid sworn affidavits made on dti designed templates; or
  - dti issued sworn affidavit; or
  - CIPC issued B-BBEE certificate.

## 4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price must be provided for **one (1) sample** (sampled sediment volume about 10L).
- 4.3 Costing must be based for the 2022/2023 financial year (ending March 2023).
- 4.4 A CPI related increase will be negotiated on an annual basis from the 01 April every year.
- 4.5 Payment will be according to the CSIR Payment Terms and Conditions.

#### 5 OTHER TERMS AND CONDITIONS

- 5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 5.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
