# 2 QUOTATION REQUIREMENTS

The CSIR green cements piloting plant requires an all terrain forklift which will be used to move materials with up to 2.5 tons in mass on hard concrete surfaces and natural ground surfaces. The forklift will be used mainly outside of sheltered spaces.

- (ii) Training on use
- (iii) 2 years warranty and
- (iv) Servicing and after care costs for 5 years

# 2.2 TECHNICAL SPECIFICATIONS:

# Operational requirements of the all-terrain forklift

- Should have forks for lifting pallets
- Should have a bucket for lifting loose materials (sand etc.)
- Should have the option for a brick grab.
- Should run on petrol or diesel.
- Should be able to operate under any weather condition.

# 3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <a href="www.csd.gov.za">www.csd.gov.za</a> to register.
- 3.3 No order will be issued or no contract will be signed without a valid CSD number.
  - Provide valid certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
  - Valid sworn affidavits made on DTIC designed templates; or
  - DTIC issued affidavit; or
  - CIPC issued B-BBEE certificate.

# 4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT) or (Inc VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

# 5 OTHER TERMS AND CONDITIONS

5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an

act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.

- 5.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 6 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
