1 INVITATION FOR QUOTATION

Quotations are hereby invited for the provision of Traffic control services to the CSIR.

2 QUOTATION REQUIREMENTS

CSIR Smart Mobility require traffic control for two weeks, including the Saturday between the two weeks (i.e. a total of 11 days). Traffic control will be on the N1 Route in the Free State Province on National Route 1, Section 15.

The project commences at Sydenham (km 28,8) and terminated at Glen Lyon (km 62,4). Sydenham is located south of Bloemfontein whilst Glen Lyon is located north of Bloemfontein. The project stretched over a distance of approximately 33,6 kilometres.

The moving road closure should be in accordance with the requirements for short term works as stated in Section 13.8.14 of the SARTSM manual, vol2., May 2012.

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.3 No order will be issued or no contract will be signed without a valid CSD number.
- 3.4 No B-BBEE scores will be allocated to service providers if they do not provide the following;
 - Valid original or certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
 - Valid sworn affidavits made on dti designed templates; or
 - dti issued sworn affidavit; or
 - CIPC issued B-BBEE certificate.

4 ELIMINATION CRITERIA

Suppliers will be eliminated under the following conditions:

- 4.1 Bidders that submit late bids will not be considered.
- 4.2 Bidders that submit to the incorrect location or email address will be eliminated.
- 4.3 Bidders that are listed on the NT database of restricted suppliers will not be considered.
- 4.4 Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- 4.5 Bidders that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT) or (Inc VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

- 6.2 A validity period of **90 days** will apply to all quotations except where indicated differently on the quote.
- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
