1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply and installation of solar meteorological station at each of the five sites located in Mpumalanga, Western cape and Northern cape. The bidder shall utilize CSIR provided equipment and remaining equipment / components sourced as part of this tender to install and commission a fully functional meteorology station.

2 QUOTATION REQUIREMENTS

The scope of this works under this quotation entails the completion of the supply and installation of the components for solar meteorological stations at the 5x sites listed in Table 1.

At 4x sites, the meteorological station shall measure global horizontal irradiation (GHI), wind speed, wind direction, temperature and humidity, barometric pressure, and rainfall. The meteorological station at 1x site (Upington) shall measure additional parameters i.e., Direct Normal Irradiance (DNI) and Diffuse Horizontal Irradiance (DHI) using CSIR provided Solys 2 tracker.

CSIR will hand over the following equipment to the selected bidder:

- a) 6x CMP 21 Pyranometers (5x for GHI measurement and 1x for DHI measurement)
- b) 1x CHP 1 Pyrheliometer for DNI measurement
- c) 1x Solys 2 tracker with power cable and 24V DC connector
- d) 5x CR 1000 Dataloggers
- e) 1x Desktop Computer




Figure 1: Meteorology station to be installed with the following components at Kendal, Majuba, Grootdraai Dam and SERE wind farm sites




Figure 2 : Meteorology station to be installed with the shown components at Upington site

Figures 1, 2 and 3 provide the details of equipment provided by CSIR and the equipment that needs to be supplied and installed by Bidder. The Kendal, Majuba, Grootdraai dam and SERE wind farm sites shall be supplied with equipment and installed as per Figure 1. The Upington site shall be supplied with equipment as per Figure 2. Please refer Table 2 for the specifications of equipment that needs to be delivered as part of this tender. Bidders shall prioritise the compatibility of the sourced new equipment with existing equipment provided by CSIR. All the stations shall be powered by solar PV panel and batteries configured appropriately to run smoothly without any intermittent shut downs.

All remaining equipment including the accessories required for mounting Pyranometers and Pyrheliometer i.e., cables, supporting assemblies, fasteners and other required spare parts shall be supplied and installed by bidder.

Access to a desktop computer at the Eskom RT&D office, Rosherville, Johannesburg for the selected bidder will be provided to establish remote connection with each of the meteorology station. The selected bidder shall install Loggernet software on the provided desktop computer and demonstrate the data access and equipment functionality from Rosherville site as a final deliverable of this tender.




Figure 3 : Remote access and Data monitoring system to be established at CSIR designated location in Johannesburg

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.3 No order will be issued or no contract will be signed without a valid CSD number.
- 3.4 No B-BBEE scores will be allocated to service providers if they do not provide the following;
 - Valid original or certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
 - Valid sworn affidavits made on dti designed templates; or
 - dti issued sworn affidavit; or
 - CIPC issued B-BBEE certificate.

4 ELIMINATION

- 4.1 Bidders that submit late bids will not be considered.
- 4.2 Bidders that submit to the incorrect location or email address will be eliminated.
- 4.3 Bidders that are listed on the NT database of restricted suppliers will not be considered.
- 4.4 Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- 4.5 Bidders that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.
- 4.6 Bidders that do not meet local production and content requirements (bidder must submit a fully completed and signed SBD 6.2 and its Annexure C), will not be considered. (When LPC is applicable)

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT) or (Inc VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 LOCAL CONTENT AND PRODUCTION

- 6.1 Only locally manufactured goods and/or services from local raw material or input will be considered.
- 6.2 If the raw material or input to be used for a specific item is not available locally, bidders should obtain written authorisation from the DTIC should there be a need to import such raw material or input.
- 6.3 A copy of the authorisation letter must be submitted together with the bid document at the closing date and time of the RFQ. For further information, bidders may contact the Electrical and Steel sector unit within the DTIC at telephone 012 394 3717/1390 during office hours.
- **6.4** The guidelines and declarations that should be used by tenderers when preparing a tender are available on the DTIC website. Guidance on the calculation of local

- 6.5 Tenderers must complete Declarations D and E, and consolidate the information on Declaration C. Annexures C, D and E must be submitted with the tender by the closing date and time as determined by the CSIR. If the tender is successful, the tenderer must continuously update Declarations C, D and E with actual values for the duration of the contract.
- 6.6 The Declaration Certificate for Local Production and Content (SBD 6.2) in addition to the above declarations must also be completed, duly signed and submitted by the bidder at the closing date and time of the tender; and
- 6.7 The rates of exchange quoted by the bidder in paragraph 6.8 below of the declaration certificate will be verified for accuracy.
- 6.8 The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) AT 12:00 on the date of advertisement of bid.
- 6.9 Only the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 must be used to calculate local content.
- 6.10 Bidders must clearly indicate in their bids, the quantities of products to be supplied, and the level of local content for each product.
- 6.11 Applicable local production and content minimum thresholds for this tender are as per the table below:

7 OTHER TERMS AND CONDITIONS

Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
