#### 1 INVITATION FOR QUOTATION

Quotations are hereby invited for the provision of IT support services for the SA-RobOTIC facility of the CSIR based in Cape Town.

## **2 QUOTATION REQUIREMENTS**

Services are required from November 2022 - end of October 2025

The service provider should be proficient in the following:

- 2.1 Server Virtualisation
- 2.2 Ubuntu Linux Server OS
- 2.3 Red Hat Linux OS
- 2.4 Proficiency with libvirt and virsh
- 2.5 Experience in live migration
- 2.6 OpenVPN setup and maintenance, key management, user support on multiple platforms
- 2.7 User management, SSH etc
- 2.8 Network knowledge, port forwarding, tunnels etc.
- 2.9 Iridium satellite network knowledge (endpoint termination, leasing with the service provider)
- 2.10 Routine maintenance and backups including rsync to off-site backups.
- 2.11 Interface with SA-RobOTIC engineers for specific project requirements
- 2.12 24-hour standby support
- 2.13 Full hardware as well as a technical support function
- 2.14 Periodic status reporting and system improvement recommendations

The appointed service provider is expected to link with the existing provider to ensure uninterrupted service during the handover process.

#### 3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <a href="www.csd.gov.za">www.csd.gov.za</a> to register.
- 3.3 No order will be issued or no contract will be signed without a valid CSD number.
- 3.4 No B-BBEE scores will be allocated to service providers if they do not provide the following;
  - Valid certificate of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
  - Valid sworn affidavits made on dtic designed templates; or
  - dtic issued sworn affidavit: or

#### 4 ELIMINATION CRITERIA

- 4.1 Bidders that submit late bids will not be considered.
- 4.2 Bidders that submit to the incorrect location or email address will be eliminated.
- 4.3 Bidders that are listed on the NT database of restricted suppliers will not be considered.
- 4.4 Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- 4.5 Bidders that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.

## 5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT) or (Inc VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

## 6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
