### **1** INVITATION FOR QUOTATION

Quotations are invited from a team of qualified South African Auditor and Training Certification Authority (SAATCA certified) service providers to conduct SHEQ Management Systems compliance audits (Internal Audits) for the CSIR.

### 2 BACKGROUND

CSIR is currently certified for ISO 9001: 2015, ISO 14001: 2015 and OHSAS 18001: 2007.

A service provider is required to conduct an audit to determine whether or not the CSIR Safety, Health, Environment and Quality Management Systems (SHEQ) conforms to the requirements of ISO 9001:2015, ISO 14001: 2015 and OHSAS 18001:2007, i.e. whether the existing standards have been properly implemented and maintained and are effective in meeting the organisation's SHEQ policy and objectives.

Quotations are hereby invited from suitable service providers, to perform the required audits for the CSIR.

## 3 SCOPE OF WORK

- 3.1 The scope of the audit is to determine whether or not the CSIR Safety, Health, Environment System (SHEMS) & Quality Management System (QMS):
  - Conforms to ISO 9001:2015, ISO 14001: 2015 and OHSAS 18001:2007 requirements;
  - Whether the above have been properly implemented and maintained;
  - Whether these are effective in meeting the organization's SHEQ policy and objectives, and
  - Service provider must provide as part of the final report, a list of identified gaps and recommendations on steps that need to be addressed in order to fulfil the gaps if any.

### 3.2 Auditor Team Composition

The team of experienced auditors must have a minimum of the following requirements:

- Lead auditor with ISO 9001:2015, ISO 14001:2015 and OHSAS 1800:2007 SAATCA registration.
- ISO 9001:2015 Auditor with SAATCA registration
- ISO 14001:2015 Auditor with SAATCA registration
- OHSAS **18001: 2007 Auditor** with a SAATCA registration

**NOTE:** The number of auditors to be used will not be restricted to the above but the 4 above is a pre-requisite.

- 5.2 Failure to submit 3 contactable references where similar audits were conducted, at least submit 3 letters on the 2015 version of the Standards (ISO 9001 and ISO 14001) as proof;
- 5.3 Failure to provide a project plan on how the audit process will be handled. (The project must be completed within two weeks after appointment by the CSIR);
- 5.4 Late submissions will not be considered; and
- 5.5 Submissions made at incorrect location will not be considered.
- 5.6 Bidders must submit proof of registration with Southern African Auditor and Training Certification Authority (SAATCA) with relevant sector codes i.e. on ISO 9001:2015; OHSAS 18001 and ISO 14001:2015;

- 7.1 Selection of suppliers will be based on the 80/20 preference point system.
- 7.2 Provide a B-BBEE Certificate, or letter of exemption indicating the B-BBEE Status level.

No B-BBEE status will equal zero points

- 7.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <u>www.csd.gov.za</u> to register.
- 7.4 No order will be issued or no contract will be signed without a valid CSD number.

### 8 PRICING QUOTATION

- 8.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated. For VAT registered bidders, the VAT component and the total price including VAT should be clearly indicated.
- 8.2 Price should be all inclusive and include additional cost elements such as travelling, accommodation, freight, insurance until acceptance, duty where applicable, etc. No variation requests will be tolerated by the CSIR.
- 8.3 Payment will be according to the CSIR Payment Terms and Conditions.
- 8.4 Price should be based on gazetted tariff of fees.

### 9 OTHER TERMS AND CONDITIONS

- 9.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 9.2 The supplier must provide the supporting relevant documents as indicated in section2.3, failure, of which they will not be evaluated on price and B-BBEE.
- 9.3 Selection of suppliers will be based on the 80/20 preference point system.
- 9.4 Provide a B-BBEE Certificate, or letter of exemption indicating the B-BBEE Status level.
