1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply and installation of Lay-up and Vacuum Infusion Equipment to the CSIR for the Composites Innovation Centre (CIC) at Tshwane University of Technology (TUT) in Pretoria.

2 QUOTATION REQUIREMENTS

a. 1 X SPEEDIVAC VACUUM DEGASSING CHAMBER VDC 12

- 12 Litres chamber capacity
- 25 cm diameter x 25 cm height
- Complete with a 10 m³ /6.0 CFM Vacuum Pump, vacuum gauge, valves and connecting pipework
- Fitted with a clear acrylic chamber top to monitor the process within the vacuum chamber
- Oil mist filter to minimise exhaust fumes

b. 2 X SPEEDIVAC RIF 12 'AUTO' RESIN INFUSION PUMP STATIONS

- 'Auto' pressure controlled sytems
- Complete Plug and Play system
- Fitted with a 5 m³ per hour /2.94 CFM dual stage Vacuum Pump, vacuum gauge, valves and connecting pipework
- 12 Litre resin trap/catch pot 25 cm diameter x 25 cm height
- Fitted with clear acrylic chamber top with 'Qwik tight' compression fitting
- Fitted with a built in pump/chamber isolation valve and vacuum release valve
- Supplied with a Vacuum Breach Unit for connection to the vacuum bag
- Oil mist filter for vacuum pump included to minimise exhaust fumes
- Resin infusion pump stations should be suitable for the aerospace, automotive and other industrial applications.

3 EVALUATION CRITERIA

- 3.4 No order will be issued or no contract will be signed without a valid CSD number.

4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions:
 - 4.3.1 The Invoice amount will be paid within forty-five (45) days after receipt of a valid Invoice, subject thereto that the Goods and/or Services fully complied with the specifications of the Purchase Order.

- 6 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
