## 1 INVITATION FOR QUOTATION

The National Foundry Technology Network (NFTN) is a Cluster Initiative, funded by the Department of Trade and Industry (the dti), and housed at the Council for Scientific and Industrial Research (CSIR). The NFTN has a mandate to manage, coordinate and facilitate transformation and development in the casting industry sub-segment, in the product supply chains, and at manufacturing companies, through focused interventions, designed to enable the Foundries.

The NFTN's vision is to increase the global competitiveness of the South African foundry industry through the provision of appropriate services, in order to reduce import leakage, increase local production, and increase investment in the sector.

#### 2 QUOTATION REQUIREMENTS

Quotations are hereby requested from experienced certification or notified bodies with expertise to audit and certify the company's manufacturing processes to comply with PED directives on their selected material scope and attaining CE Marking for relevant categories at Vestcast Foundry.

Vestcast is one of the leading investment casting producers in SA. The foundry can cast mostly if not all both ferrous and non-ferrous castings up 6000kg by weight castings. The foundry can supply the valves to the ASME, EN and BS material specification codes. The valve components can range from 10kg up to 6000kg by weight. They supply to the petrochemical, medical, mining, general engineering, pump and valve industry. The foundry is ISO 9001:2008 accredited by TUV Rheinland. The foundry is located in Gauteng.

Specific services needed are the following:

The certification process should include surveillance audits and recertification as part of the quotation. Notified body registration number shall be presented on the quotation with a minimum list of two previously and successfully PED audited companies in South Africa.

## 3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Provide a B-BBEE Certificate, or letter of exemption indicating the B-BBEE Status level.
  No B-BBEE status will equal zero points.
- 3.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <a href="https://www.csd.gov.za">www.csd.gov.za</a> to register.
- 3.4 No order will be issued or no contract will be signed without a valid CSD number.

## 4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated. The VAT must be clearly indicated for bidders that are not VAT exempted.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

## 5 OTHER TERMS AND CONDITIONS

5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an

- act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 5.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 6 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
