# 1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply of goods and/or services to the CSIR.

## **2 QUOTATION REQUIREMENTS**

There is a need to appoint a specialist to supply an up-to-date routable street centreline network for SA which is used as input to the various geographic models used by the Urban and Regional Dynamics research group in the Smart Places Cluster.

## 3 ELIMINATION CRITERIA

Quotations will to be eliminated under the following conditions;

Data set	Description
Street centreline network	<ul> <li>An up-to-date street centre line road network for the whole of South Africa.</li> <li>As recent as September 2020 (November). This dataset must also provide the following key features: <ul> <li>It must be routable for scheduling and delivery purposes.</li> <li>Provide average speed and travel times for each link in the dataset.</li> <li>Provide direction (one-way or bi-directional) for each link in the dataset.</li> <li>Clear and comprehensive metadata for the dataset (links).</li> <li>Includes street, suburb, town, municipality and province names for each street link.</li> <li>Includes all categories of roads and streets for all towns and major metropolitan areas in South Africa.</li> <li>It must be available in a recognised spatial data format.</li> </ul> </li> </ul>

- 3.1 Submission after the deadline;
- 3.2 Proposals submitted at an incorrect email address;

#### 4 EVALUATION CRITERIA

- 4.1 Selection of suppliers will be based on the 80/20 preference point system.
- 4.2 Indicate valid B-BBEE status on quotation. No B-BBEE status will equal zero points.
- 4.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <a href="www.csd.gov.za">www.csd.gov.za</a> to register.
- 4.4 No order will be issued or no contract will be signed without a valid CSD number.

#### 5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

## 6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
- 8 Note: This is not a Purchase Order.
