1 INVITATION FOR QUOTATION

Quotations are hereby invited for the once-off supply of an equipment – Quorum Rotary-Pumped Sputter Coater.

2 QUOTATION REQUIREMENTS

05Q150RSPLUS description

Fully automatic, capacitive touchscreen controlled rotary pumped sputter coater with status LED indicator. Including 10587 quick release sputter insert and one SC502-314A 57mm diameter x 0.1mm gold target. 10067 rotating specimen stage, 50mm diameter, supplied as standard.

PFEIFFER DUO 6 5 M3/HR ROTARY VACUUM PUMP DESCRIPTION

50L/s two-stage rotary pump, with vacuum hose, coupling kit and oil mist filter

Quorum Rotary-Pumped Sputter Coater - is capable of achieving vacuum of 2 x 10-2 mbar. It has a new touch swipe capacitive screen, USB port for upgrades and download of log files, Multiple-user profiles that can be set up on one machine, new software sorts recipes per user, 16GB of memory that can store more than 1000 recipes, new multi-colour LED visual status indicator and Interchangeable stage options and plug-in heads.

The instrument also allows multiple users to input and store coating recipes, with a new feature to sort recipes per user. The software can detects failure to achieve vacuum in a set period of time and shuts down the process in case of vacuum leak, which ensures pump protection from overheating.

- 3.4 No order will be issued or no contract will be signed without a valid CSD number.

4 ELIMINATION CRITERIA

Suppliers will be disqualified under the following conditions:

- Late submission;
- Quotation submitted at wrong location or email address (Quote must submitted via email to tender@csir.co.za before the closing date and time);
- Bidders that did not price according quotation requirements.

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS

6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an
