2 QUOTATION REQUIREMENTS

14x AMD Ryzen 9 3900XT CPU

14x x570 based motherboard - preferably Gigabyte, Asus or MSI

14x 512Gb SSD hard drive

14x AM4 compatible CPU cooler - preferably either the Cooler Master MasterAir MA410P or Cooler Master Hyper 212 RGB Black Edition

14x Mid Tower Chassis - preferably the Cooler Master MasterBox TD500 or Corsair Carbide SPEC-02 or Corsair 110R - the case has to have good airflow from the front to the back

28x 120mm case fan - preferably Cooler Master or Corsair branded

14x 750W PSU Gold Rated modular PSU - Antec, Corsair or Cooler Master

14x 32Gb DDR4 3600Mhz RAM kits - preferably 4x8Gb modules

14x Geforce GT 710 GPU - alternatively GT 1030 GPUs

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Please take note that the submitted BBBEE Certificate should be SANAS Accredited or Sworn Affidavit with the dti template. Any Certificate which is not as mentioned will not be considered for evaluation
- 3.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <u>www.csd.gov.za</u> to register.
- 3.4 No order will be issued or no contract will be signed without a valid CSD number.
- 3.5 Elimination criteria;

Suppliers will be disqualified under the following conditions:

- Late submission;
- Quotation submitted at wrong location or email address (Quote must submitted via email to tender@csir.co.za before the closing date and time);

4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.
- 4.4 No pre-payment will be made before the delivery of goods or services.

5 OTHER TERMS AND CONDITIONS

5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such

an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.

- 5.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 6 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
