- 4.1 Suppliers who do not submit a detailed BOM with pricing will not be evaluated.
- 4.2 Suppliers that submit quotes late will not be evaluated.
- 4.3 Suppliers that submit to the incorrect email address will not be evaluated.
- 4.4 Suppliers who do not submit a completed SBD 1 form will not be evaluated.
- 4.5 Suppliers who do not submit a completed Declaration by Tenderer form will not be evaluated.
- 4.6 Only suppliers that quote as per specification will be evaluated.
- 4.7 Selection of suppliers will be based on the **80/20** preference point system.
- 4.8 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register. No order will be issued or no contract will be signed without a valid CSD number.
- 4.9 No order will be issued or no contract will be signed without a valid B-BBEE Certificate.
 - Provide valid original or certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
 - Valid sworn affidavits made on DTI designed templates; or
 - DTI issued sworn affidavit; or
 - CIPC issued B-BBEE certificate.

4.10 The bidder must be an authorised Supermicro distributor/reseller. Proof thereof must be attached to the quotation. Failure to provide this will result in the quote not being considered.

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 A validity period of 90 days will apply to all quotations.
- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
