 - Temperature of the off gas: between 25 40 deg C.
 - Relative humidity measurement to compensate for humidity and temperature effects.
 - Automatic or manual calibration.
 - 4-8 input channels.
 - o Compatible for use with 3 x existing Biostat C-DCU (30L) bioreactors.
- Software
 - Stand-alone software.

- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.
