1 INVITATION FOR QUOTATION

Quotations are hereby invited from bridge engineers with Committee of Transport Officials (COTO) Structures Committee accreditation as a Senior Bridge Inspector to assist the CSIR with the training of staff from Namport in Walvis Bay, Namibia in the visual assessment of port structures using the DER rating methodology.

2 QUOTATION REQUIREMENTS

- The engineer must be <u>accredited</u> as a Senior Bridge Engineer by the COTO Structures Committee and proof of such accreditation must be included with the quotation.
- The Senior Bridge Inspector will be required to make presentations as part of the theoretical training (one day) and to conduct the practical training (three days)

3 EVALUATION CRITERIA

3.1 The engineer must be accredited as a Senior Bridge Engineer by the DoT's Committee of Transport Officials (COTO) Structures Sub-committee and proof of such accreditation must be included with the quotation. Failure to provide proof will result in elimination.

- 3.2 Selection of suppliers will be based on the 80/20 preference point system.
- 3.3 Indicate valid B-BBEE status on quotation. No B-BBEE status will equal zero points.
- 3.4 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <u>www.csd.gov.za</u> to register.
- 3.5 No order will be issued or no contract will be signed without a valid CSD number.


4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Payment will be according to the CSIR Payment Terms and Conditions.

5 OTHER TERMS AND CONDITIONS
