1 INVITATION FOR QUOTATION

Quotations are hereby invited from building contractors to supply and erect Aluminium and Glass Partitions at building 17 at CSIR Pretoria Campus.

2 SCOPE OF WORK AND QUOTATION REQUIREMENTS

The scope of work and BOQ are detailed below.

NOTES: All Aluminium work to be manufactured and installed as per The Association of Architectural Aluminium Manufacturers of South Africa (AAAMSA) specifications. Glazing, clear laminated intruder proof (glazing thickness as per SANS 10400, Part N, Glazing), South African Glass and Glazing Association (SAGGA) certified and

coded on completion.

Door closer to opening leafs where applicable, model to suit weight of door.

The supplier must quote as per the below Bill of Quantities (BOQ) which should be read in conjunction with the accompanying drawing: (Please see **Annexure A** attached).

Additional Requirements:

- The supplier must submit quotation on their official company letterhead.
- The supplier must quote on all the items/services exactly as listed in the above BOQ or scope of work.
- The pricing must be firm and inclusive of all costs required to render the required services to the CSIR.

Mandatory documents required / returnable:

- Current company profile clearly showing the company's core activities. The
 profile must highlight the expertise of the contractor in Aluminium works. It
 must also include a minimum of three (3) Aluminium maintenance and
 installation services or services done in the last 2 to 3 years.
- The service provider must provide a minimum of three (3) contactable references for similar work or services (Scope and value) done in the last 2 to 3 years. These references must include contactable telephone numbers and email addresses of the referees.
- Proof of compliance with the Compensation for Occupational Injuries and Disease Act (COID). Please submit proof.

Proof of CIDB registration 1GB or Higher

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Provide a certified copy of a valid B-BBEE Certificate, or valid sworn affidavit indicating the B-BBEE Status level. B-BBEE certificate must be issued by SANAS accredited agency or a valid sworn affidavit in line with DTI regulations. (RSA suppliers only).
- 3.3 No B-BBEE status will equal zero points.
- 3.4 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.5 No order will be issued or no contract will be signed without a valid CSD number.

Elimination Criteria:

Suppliers will be eliminated under the following conditions:

- Late submission of Quotes;
- If supplier does not quote on all items in the BOQ;
- If supply does not submit quotation on their official company letterhead;
- Submission at wrong location or incorrect email address (Please submit electronically to tender@csir.co.za);
- Non-submission of relevant company profile;
- Non-submission of at least a minimum of three (3) testimonial letters on similar work done;
- If the supplier fails to submit any of the mandatory/returnable documents.

4 PRICING QUOTATION

4.1 Price needs to be provided in South African Rand (excl. VAT), with details on

price elements that are subject to escalation and exchange rate fluctuations

clearly indicated.

4.2 Price should include additional cost elements such as freight, insurance until

acceptance, duty where applicable, etc.

4.3 Payment will be according to the CSIR Payment Terms and Conditions.

The price should be firm and inclusive of costs and all services required to

complete the project.

5 SUB-CONTRACTING

5.1 A tenderer will not be awarded points for B-BBEE status level if it is indicated in

the tender documents that such a tenderer intends sub-contracting more than

25% of the value of the contract to any other enterprise that does not qualify for

at least the points that such a tenderer qualifies for, unless the intended sub-

contractor is an exempted micro enterprise that has the capability and ability to

execute the sub-contract.

5.2 A tenderer awarded a contract may not sub-contract more than 25% of the value

of the contract to any other enterprise that does not have an equal or higher B-

BBEE status level than the person concerned, unless the contract is sub-

contracted to an exempted micro enterprise that has the capability and ability to

execute the sub-contract.

5.3 If the tender intends to sub-contract, they must indicate the value of the work in

Rands to be sub-contracted in relation to the total tendered amount. The

supplier must also indicate the name(s) of the company / contractor.

5.4 All BBBEE certificates of the sub-contractors must also be submitted. Non-

submission will result in 0 points being awarded for BBBEE.

5.5 In case of proposal from a joint venture, the following must be submitted

together with the proposal/Quotation:

Joint venture Agreement including split of work signed by both parties;

• The original or certified copy of the B-BBEE certificate of the joint venture;

The Tax Clearance Certificate of each joint venture member;

Proof of ownership/shareholder certificates/copies; and

• Company registration certificates.

6 OTHER TERMS AND CONDITIONS

6.1 The supplier shall under no circumstances offer, promise or make any gift,

payment, loan, reward, inducement, benefit or other advantage, which may be

construed as being made to solicit any favour, to any CSIR employee or its

representatives.

6.2 Such an act shall constitute a material breach of the Agreement and the CSIR

shall be entitled to terminate the Agreement forthwith, without prejudice to any

of its rights.

7 No goods and/or services should be delivered to the CSIR without an

official CSIR Purchase order. Note: This is not a Purchase Order.
