1 INVITATION FOR QUOTATION

Quotations are hereby invited for the Provision of Three (3) software licenses to the CSIR Stellenbosch Campus.

2 QUOTATION REQUIREMENTS

2.1 The Provision of **three** software licenses to the CSIR Stellenbosch Campus.

Specification:

- Electrical CAD software – Zuken E3
 - E3 Panel (No Routing) Floating: E3.PAN-SF-L
 - E3 Enterprise (Multi-User) including PDF output: E2-CAB-E-SF-L
- Three years annual maintenance contracts (AMC) for all licenses.

Additional information:

- The supplier must submit quotation on their official company letterhead.
- The supplier must quote on all the items as listed.
- The pricing must be firm and inclusive of all costs required to render the required services to the CSIR.

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Provide a SANAS certified copy of a valid B-BBEE Certificate, or valid sworn affidavit on DTIC Template. (RSA suppliers only).
- 3.3 No B-BBEE status will equal zero points.
- 3.4 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.5 No order will be issued or no contract will be signed without a valid CSD number.

4 ELIMINATION CRITERIA

Suppliers will be eliminated under the following conditions:

- Late submission of Quotes;
- Suppliers on National Treasury list of restricted suppliers.
- Submission at wrong location or incorrect email address (***Please submit in PDF format electronically to tender@csir.co.za***);

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an

act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.

- 6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.

- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.

- 8 **Note: This is not a Purchase Order.**
