2 QUOTATION REQUIREMENTS

Specifications	
CAVITY	
Useful spectral range 400-800 nm, or as much of this range as possible	
The cavity must be formed by two spherical mirrors, each with a radius of curvature equal	
to the spacing between the mirrors (that means a confocal cavity).	
The structure of the cavity must be made of Ultrastable Athermal Invar	
The mirror substrates must be made of UV fused silica	
Mirror reflectance must be larger than 99.3% over the useful spectral range	
Mirror finesse must be larger than 250 over the useful spectral range	
The free spectral range of the interferometer must be 10 GHz (10 ¹⁰ Hz).	
Finesse of interferometer must be larger than 150	
The resolution must be 67 MHz (67x10 ⁶ Hz) or smaller	
Cavity length must be equal to 7.5 mm or larger than this, but not smaller	
DETECTOR	
A photodiode that can be mounted onto the cavity or removed by the user must be	
supplied	
A cable ending in a BNC connector to connect the photodiode to an oscilloscope must be	
supplied

SCANNING

Scanning of the distance between the mirrors must be possible by means of piezoelectric transducer

A cable ending in a BNC connector to apply the voltage to the piezoelectric transducer must be supplied

Minimum scanning range must be three times the free spectral range

Please take note of the following:

- Delivery, warranties, installation and training must be included
- The machine must come with a manual
- Add the brochure to the quotation (<u>quotations without brochures will not be</u> <u>considered</u>)
- Clearly indicate VAT charged where applicable (if not VAT registered please state so clearly)

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Please send a valid B-BBEE certificate with quotation. No B-BBEE status will equal zero points.

- 3.4 No order will be issued or no contract will be signed without a valid CSD number.

4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

5 OTHER TERMS AND CONDITIONS

5.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such
