1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply of **DC Withstand Voltage Tester for testing solar PV modules** to the CSIR.

2 QUOTATION REQUIREMENTS

The supplier is required to provide the CSIR with an **DC Withstand Voltage Tester.** The tester must have the following features:

- 1) Dielectric withstand test mode
 - Output rating 12kV @ 10 mA DC
 - Voltage display range: 0 12 kV Full scale
 - Accuracy: +/- 2% of reading + 20 V

- Ground continuity: Max. Ground Resistance 1 Ω ± 0.1 Ω , fixed
- Ground fault interrupt (GFI): HV Shut Down Speed < 1 ms, GFI Trip Current 1
 mA max

2) General requirements

- Input: 230 VAC +/- 10 %, single phase
- Frequency: 50 Hz +/- 5 %
- Interface: Standard USB / RS-232, Optional GPIB
- Memory: 50 memories w/8 steps per memory
- Operation mode: Run tests from user interface or automate with a PC

The supplier must indicate if the quoted equipment adheres to the specifications and all requirements as mentioned above.

3) Handheld / portable geiger counter

In addition to DC Withstand Voltage Tester may you please provide the CSIR with another separate quotation for a handheld / portable geiger counter that measures low doses of alpha, gamma and beta radiation.

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.3 No order will be issued or no contract will be signed without a valid CSD number.
- 3.4 No B-BBEE scores will be allocated to service providers if they do not provide the following;
 - Valid original or certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
 - Valid sworn affidavits made on dti designed templates; or
 - dti issued sworn affidavit; or
 - CIPC issued B-BBEE certificate.

4 ELIMINATION CRITERIA

- 4.1 Bidders that submit late bids will not be considered.
- 4.2 Bidders that submit to the incorrect location or email address will be eliminated.
- 4.3 Bidders that are listed on the NT database of restricted suppliers will not be considered.
- 4.4 Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- 4.5 Bidders that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT) or (Inc VAT) where applicable, with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS

6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an

act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.

6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.

7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
