1 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply and install of the Manual OR Automatic Bomb Calorimeter to the CSIR (BIDF) in Durban.

2 QUOTATION REQUIREMENTS

The bidder will supply and install the equipment at CSIR in Durban.

NB!!! Please separate the quotations if you offer both Automatic and Manual Bomb Calorimeters

NB!!! We need the calorimeter that will be used with most applications including, but not limited to: Sawdust analysis, Coal analysis, Charcoal analysis, Biochar analysis, food analysis, oil analysis, etc.

NB!!! 3 years 100 % Maintenance plan, please provide a list of what it entails

- The bidder *must* be an Authorised representative of the original equipment manufacturer (OEM) supplier.
- The bidder must be able to provide proof that they can supply after sales service.
- The bidder **must** be able to provide training: Full installation and training with certificates for minimum of 2 or 3 people
- Delivery: Should be within 2-6 weeks of receiving the order number

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the **80/20** preference point system.
- 3.2 Provide a valid copy of a B BBEE Certificate or valid affidavit. No B BBEE status will equal to zero points. B BBEE certificate must be issued by SANAS accredited agency or a valid sworn affidavit in line with DTIC regulations. (RSA suppliers only).

B BBEE Verification Agency issued Certificate can be verified on SANAS website on Verification Agency (B BBEE) under Accredited Facilities (Quick Access Links): https://www.sanas.co.za/Pages/index.aspx to check validity of the B BBEE Certificate.

- 3.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.4 No order will be issued, or no contract will be signed without a valid CSD number

4 Elimination criteria

- 4.1 Late submission of quotes
- 4.2 Failure to adhere to quotation specifications
- 4.3 Submission at the wrong location or incorrect email address submissions must be made electronically to tender@csir.co.za
- 4.4 If the bidder is listed on the NT database of restricted suppliers.
- 4.5 If the bidder is registered on the NT Register of Tender Defaulters.
- 4.6 If the bidder did not submit a fully completed and signed SBD 1 and SBD 4 Forms

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
- 8 Note: This is not a Purchase Order.
