### 1 INTRODUCTION

The Council for Scientific and Industrial Research (CSIR) is one of the leading scientific research and technology development organisations in Africa. In partnership with national and international research and technology institutions, the CSIR undertakes directed and multidisciplinary research and technology innovation that contributes to the improvement of the quality of life of South Africans. The CSIR's main site is in Pretoria while it is represented in other provinces of South Africa through regional offices.

CSIR Environmental Management Services, based in Stellenbosch, hereby invites tenders from suitably qualified service providers to undertake a scoping-level avifauna assessment of focus areas identified through the Department of Forestry, Fisheries and the Environment (DFFE) Phase 3 National Strategic Environmental Assessment (SEA) for the efficient and effective rollout of wind and solar photovoltaic (PV) energy.

### 2 INVITATION FOR QUOTATION

Quotations are hereby invited for the supply of avifauna specialist (with a strong focus on vulture electrocution risk in the Eastern Cape) services to the CSIR.

#### BACKGROUND:

In 2012, Cabinet adopted the National Development Plan (NDP), which provided South Africa's plan to accelerate infrastructure development to address service delivery backlogs and facilitate economic growth and job creation. The NDP would be achieved through the implementation of Strategic Integrated Projects (SIPs). Linked to this, to ensure that, when required, Environmental Authorisations (EAs) are not a cause for delay, the former Department of Environmental Affairs (DEA) (later operating as the Department of Environment, Forestry and Fisheries (DEFF), and currently operating as the DFFE) and other government departments embarked on a program of commissioning SEAs for large scale developments and to support various Government priority projects. These projects included the SIPs, Operation Phakisa initiative, Infrastructure Build Programme, Extended Public Works Programme and the Renewable Energy Independent Power Producers Procurement Programme (REIPPPP) for procuring renewable energy linked to the Integrated Resource Plan (IRP). These SEAs were aimed to pre-assess environmental sensitivities within the proposed development or geographical areas at a regional scale to plan and simplify the site-specific Environmental Impact Assessments (EIAs) when they are undertaken and to focus the assessment requirements on the sensitivity of the sites. To date, the DFFE, through the CSIR and the South African National Biodiversity Institute (SANBI), has successfully undertaken several national-scale SEAs for the South African aquaculture industry, Electricity Grid Infrastructure (EGI), natural and shale gas, and renewable energy (wind and solar photovoltaic (PV)) industry sectors.

This current proposed SEA builds on the 2015 Phase 1 Wind and Solar PV SEA and 2019 Phase 2 Wind and Solar PV SEA.




Figure 1: Phase 1 Renewable Energy Development Zones

Eight Renewable energy Development Zones (REDZs) were identified and assessed as part of the Phase 1 Wind and Solar (Figure 1), as indicated below:

- FA 1: Overberg
- FA 2: Komsberg

- FA 3: Cookhouse
- FA 4: Stormberg
- FA 5: Kimberley
- FA 6: Vryburg
- FA 7: Upington
- FA 8: Springbok.

These eight REDZs were gazetted for implementation on 16 February 2018 in Government Notice No. 114 in Government Gazette No. 41445. The Gazette documented notice given by the Minister of Environmental Affairs of alternative procedures to be followed when applying for EA for large scale wind and solar PV facilities, identified in terms of section 24(2)(a) of the National Environmental Management Act (Act 107 of 1998, as amended) (NEMA) in the identified REDZs (i.e. areas declared as geographical areas of strategic importance). The alternative procedures referred to include undertaking a Basic Assessment (BA) Process instead of a full Scoping and EIA Process for wind and solar PV development in the REDZs triggering relevant listed activities in Listing Notice 2 of the 2014 NEMA EIA Regulations (as amended). The decision-making timeframe for such Applications for EA in the eight REDZs was also reduced from 107 days to 57 days.

In 2019, a Phase 2 Wind and Solar SEA was completed, which resulted in the identification of three additional REDZs, which were published for consultation on 17 July 2020 in Government Gazette 43528, Government Notice 786. The procedures to be followed within these three additional REDZs




Figure 2: Phase 2 Renewable Energy Development Zones

(i.e. BA Process with 57 days decision-making) were gazetted for consultation on 31 July 2020 in Government Gazette 43571, Government Notice 841. On 26 February 2021, in Government Gazette 44191, Government Notice 144, the Minister of Forestry, Fisheries and the Environment, gazetted the three additional REDZs, in terms of Section 24(3) of the NEMA, as areas of strategic importance when planning large scale wind and solar PV energy facilities as indicated below (Figure 2):

- FA 9: Emalahleni
- FA 10: Klerksdorp
- FA 11: Beaufort West.




Figure 3: The five gazetted EGI corridors (gazetted in 2018) and the Expanded Western and Eastern EGI Corridors (as an outcome of the 2019 EGI Expansion SEA gazetted in 2021), as well as the 11 REDZs.

Linked to the two SEAs listed above, the CSIR undertook SEAs for identifying Strategic Transmission Corridors (hereinafter referred to as EGI Corridors). These SEAs assessed environmental sensitivities in these corridors for large scale electricity transmission and distribution development activities. Five EGI corridors were gazetted for implementation on 16 February 2018 and two expanded EGI corridors were gazetted on 29 April 2021 (Figure 3). The Gazette documented notice given by the Minister of Environmental Affairs of alternative procedures to be followed when applying for EA for large scale electricity transmission and distribution development activities, identified in terms of section 24(2)(a) of the National Environmental Management Act (Act 107 of 1998, as amended) (NEMA) in the identified EGI Corridors (i.e. areas declared as geographical areas of strategic importance). The alternative procedures referred to include undertaking a Basic Assessment (BA) Process instead of a full Scoping and EIA Process for EGI development in the EGI corridors triggering relevant listed activities in Listing Notice 2 of the 2014 NEMA EIA Regulations (as amended). The decision-making timeframe for such Applications for EA in the five EGI corridors was also reduced from 107 days to 57 days.

### SCOPE OF WORK

The detailed scope of work is outlined under Annexure A

Quotes are requested for avifauna assessment related to vulture electrocution risk in the Stormberg and Cookhouse REDZs for:

 reviewing the Stormberg and Cookhouse REDZs in the Eastern Cape to identify electricity grid infrastructure which poses an electrocution risk to Cape Vultures and to formulate a mitigation plan.

The <u>outcome</u> of this work is to allow for:

- maps identifying areas where additional mitigation measures must be applied or where the design
  of electricity power lines must be amended to avoid vulture collisions or electrocutions in the
  Stormberg and Cookhouse REDZs.
- mitigation measures are to be provided and costed. This work will be required to be undertaken in close consultation with relevant NGOs, Eskom and the wind and solar energy associations

#### **3 PRICING REQUIREMENTS**

- 3.1 Pricing must be provided in South African Rand (including all applicable taxes less all unconditional discounts).
- 3.2 Prices that are subject to escalation and exchange rate fluctuations are to be clearly indicated, with the currency and ROE used in the quotation must be clearly indicated.

**CSIR** Tender Documentation

- 3.3 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 3.4 Payment will be according to the <u>CSIR Payment Terms and Conditions</u>.
- 3.5 Please provide a detail pricing using a Pricing Schedule/outlined under **Annexure B.**

Bidders are to price their quotations using the Pricing Schedule. Explanatory notes must be provided in the quotation when deviating from the Pricing Schedule

#### 4 RETURNABLES

Returnables are required for evaluation purposes. Bidders' responses will be evaluated based on compliance with the listed administration and mandatory bid requirements. The bidder(s) proposal may be disqualified for non-submission of any of the documents.

### 5 EVALUATION PROCESS AND CRITERIA

The RFQ will be evaluated as per the following:

### Phase 1 – Elimination Criteria

The bidders will be evaluated on the elimination criteria as stated in Point 5.1 below. Bidders that are eliminated during this phase will not be evaluated further on price and preference points.

### Phase 2 – Price and Preference Points Evaluation

Bidders will be evaluated as per the preference points system stated in point 5.2 below.

### 5.1 Elimination Criteria

Bidders will be eliminated if they fail to provide the following information:

- a) Bidder that submit late bids will not be considered.
- b) Bidder that submit to the incorrect location or email address will not be considered.
- c) Bidder that is listed on the NT database of restricted suppliers will not be considered.
- d) Bidder that is registered on the NT Register of Tender Defaulters will not be considered.
- e) Bidder that did not submit mandatory returnable documents as listed on paragraph 4.2 (Table 2).
- f) Bidder that fail to meet the specification requirements will not be considered.

### 5.2 **Preferential Points System Evaluation Criteria**

Selection of suppliers will be based on the 80/20 preference point system as stipulated in **Annexure E: Preference Points Award Form**.

### 6 OBJECTIVE CRITERIA

The CSIR reserves the right to award this tender to a bidder that did not score the highest total number of points in accordance with Section (2) (1) (f) of the PPPFA (Act 5 of 2000)", under the following conditions:

• The directors, shareholders or officers of the bidder must not be formally charged of fraudulent or illegal conduct which could harm the CSIR's reputation by associating with the bidder.

### 7 SUBMISSION REQUIREMENTS

- 7.1 All quotations must be submitted electronically to tender@csir.co.za
- 7.2 Respondents must use the RFQ number and RFQ Description as the subject reference number when submitting their bids.

- 7.3 The email and file sizes must not exceed a total of 25MB per email.
- 7.4 Documents submitted via cloud solutions such as: WeTransfer, Google Drive, Dropbox, etc. will not be considered.
- 7.5 The naming / labelling syntax of files or documents must be short and simple.

### 8 MEDIUM OF COMMUNICATION

All documentation submitted in response to this RFQ must be in English.

### 9 CORRECTNESS OF RESPONSES

- 9.1 The bidder must confirm satisfaction regarding the correctness and validity of their proposal and that all prices and rates quoted cover all the work/items specified in the RFQ. The prices and rates quoted must cover all obligations under any resulting contract.
- 9.2 The bidder accepts that any mistakes regarding prices and calculations will be at their own risk.

### 10 VERIFICATION OF DOCUMENTS

- 10.1 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by the CSIR in regard to anything arising.
- 10.2 Pricing schedule and specific goals credentials should be submitted with the RFQ response.

#### 11 PREPARATION COSTS

The Bidder will bear all its costs in preparing, submitting and presenting any response or Tender to this bid and all other costs incurred by it throughout the bid process. Furthermore, no statement in this bid will be construed as placing the CSIR, its employees or agents under any obligation whatsoever, including in respect of costs, expenses or losses incurred by the bidder(s) in the preparation of their response to this bid.

#### 12 OTHER TERMS AND CONDITIONS

- 12.1 No bidder shall under any circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 12.2 Bidders shall not assume that information and/or documents supplied to CSIR, at any time prior to this request, are still available to CSIR, and shall consequently not make any reference to such information document in its response to this request.
- 12.3 Changes by a bidder to its submission will not be considered after the closing date and time.

**CSIR** Tender Documentation

- 12.4 Bidders confirm that by submitting a tender, they confirm that I am satisfied with regards to the correctness and validity of my quotation; that the price(s) and rate(s) quoted cover all the services specified in the quotation documents; that the price(s) and rate(s) cover all my obligations and I accept that any mistakes regarding price(s) and rate(s) and calculations will be at my own risk.
- 12.5 Bidders further confirm that by submitting a tender, they accept to take accept full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on them under this RFQ as the principal liable for the due fulfilment of this RFQ process.
- 12.6 No goods and/or services shall be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to the supplier.

### 13 SPECIAL CONDITIONS

The CSIR reserves the right to

- 14.1. Extend the closing date of this RFQ;
- 14.2. Correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process;
- 14.3. Verify any information contained in the bidder's submission;
- 14.4. Request documentary proof regarding the bidder's submission;
- 14.5. Carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the product/service offered by the bidder(s) or verify any information whether before or after the adjudication of this RFQ;
- 14.6. Award this tender to a bidder that did not score the highest total number of points, only in accordance with Section 2(1)(f) of the PPPFA (Act 5 of 2000);
- 14.7. Request audited financial statements or other documents for the purpose of a due diligence exercise to determine if the bidder will be able to execute the contract;
- 14.8. Award this RFQ as a whole or in part;
- 14.9. Award this RFQ to multiple bidders;
- 14.10. Cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such;
- 14.11. Post tender negotiate on any elements on the bid, including but not limited to technical, transformation, price, and contractual terms and conditions.;
- 14.12. Not to award a contract to a bidder who is associated with a security breach that materially adversely affects other entities or if any directors or officers of a bidder are formally charged of fraudulent or illegal conduct which, would harm the CSIR's reputation by its continued association with the bidder.

### 14 CONFIDENTIALITY

Some of the information contained in the Tender Documents may be of a confidential nature and must only be used for purposes of responding to this RFQ. This confidentiality clause extends to bidder partners whom you may decide to involve in preparing a response to this RFQ. Bidders must complete and sign **ANNEXURE F:** Non- Disclosure Agreement.

CSIR Tender Documentation Except as may be required by operation of law, by a court or by a regulatory authority having appropriate jurisdiction, no information contained in or relating to this bid or a bidder's tender(s) will be disclosed by any bidder or other person not officially involved with the CSIR's examination and evaluation of a Tender.

No part of the bid may be distributed, reproduced, stored or transmitted, in any form or by any means, electronic, photocopying, recording or otherwise, in whole or in part except for the purpose of preparing a Tender. This bid and any other documents supplied by the CSIR remain proprietary to the CSIR and must be promptly returned to the CSIR upon request together with all copies, electronic versions, excerpts or summaries thereof or work derived there from.

Throughout this bid process and thereafter, bidder(s) must secure the CSIR's written approval prior to the release of any information that pertains to (i) the potential work or activities to which this bid relates; or (ii) the process which follows this bid. Failure to adhere to this requirement may result in disqualification from the bid process and civil action.

### 15 PROTECTION OF PERSONAL INFORMATION

- 15.1 Each Party consents to the other Party holding and processing "personal information" (as defined in the POPI Act) relating to it for legal, personnel, administrative and management purposes (including, if applicable, any "special personal information" relating to him/her, as defined in the POPI Act). Notwithstanding the generality of the aforesaid, each Party hereby undertakes to comply with all relevant provisions of the POPI Act and any other applicable data protection laws. The Client further agrees to comply with all CSIR's reasonable internal governance requirements pertaining to data protection.
- 15.2 Each Party consents to the other Party making such information available to those who provide products or services to such parties (such as advisers, regulatory authorities, governmental or quasi-governmental organisations and potential purchasers of such Party or any part of their business).
- 15.3 The Client consents to the transfer of such information to CSIR's business contacts outside South Africa in order to further its business interests.

The CSIR shall be entitled on reasonable notice to conduct an inspection or audit Client's compliance with the requisite POPI Act safeguards.

### 16 INDEMNITY

If a bidder breaches the conditions of this bid and, as a result of that breach, the CSIR incurs costs or damages (including, without limitation, the cost of any investigations, procedural impairment, repetition of all or part of the bid process and/or enforcement of intellectual property rights or confidentiality obligations), then the bidder indemnifies and holds the CSIR harmless from any and all such costs which the CSIR may incur and for any damages or losses the CSIR may suffer.

### 17 TAX COMPLIANCE

No tender shall be awarded to a bidder who is not tax compliant. If a recommended bidder is not tax complaint, the bidder will be notified in writing of their non- compliant status and the bidder will be requested to submit written proof from SARS of their tax compliant status or proof that they have made an arrangement to meet their outstanding tax obligations within seven (7) working days. Should they fail to do so CSIR will reject their bid.

The CSIR reserves the right to withdraw an award made, or cancel a contract concluded with a successful bidder in the event that it is established that such bidder was in fact not tax compliant at the time of the award or has submitted a fraudulent Tax Clearance Certificate to the CSIR, or whose verification against the Central Supplier Database (CSD) proves non-compliant. The CSIR further reserves the right to cancel a contract with a successful bidder in the event that such bidder does not remain tax compliant for the full term of the contract.

#### 18 LIMITATION OF LIABILITY

A bidder participates in this bid process entirely at its own risk and cost. The CSIR shall not be liable to compensate a bidder on any grounds whatsoever for any costs incurred or any damages suffered as a result of the Bidder's participation in this Bid process.

### 19 MISREPRESENTATIONS DURING THE LIFECYCLE OF THE CONTRACT

- 19.1 The bidder should note that the terms of its Tender will be incorporated in the proposed contract by reference and that the CSIR relies upon the bidder's Tender as a material representation in making an award to a successful bidder and in concluding an agreement with the bidder.
- 19.2 It follows therefore that misrepresentations in a Tender may give rise to service termination and a claim by the CSIR against the bidder notwithstanding the conclusion of the Service Level Agreement between the CSIR and the bidder for the provision of the Service in question. In the event of a conflict between the bidder's proposal and the Service Level Agreement concluded between the parties, the Service Level Agreement will prevail.

This RFQ is a request for Quotations only and not an offer document. Answers to this RFQ must not be construed as acceptance of an offer or imply the existence of a contract between the parties. By submission of its proposal, bidders shall be deemed to have satisfied themselves with and to have accepted all Terms & Conditions of this RFQ. The CSIR makes no representation, warranty, assurance, guarantee or endorsements to bidder concerning the RFQ, whether with regard to its accuracy, completeness or otherwise and the CSIR shall have no liability towards the bidder or any other party in connection therewith.

### 1. SCOPE OF WORK

This current proposed SEA, hereafter referred to as the **<u>REDZs Extension SEA</u>**, is focused on improving the effectiveness of the REDZs by:

 reviewing the Stormberg and Cookhouse REDZs in the Eastern Cape to identify electricity grid infrastructure which poses an electrocution risk to Cape Vultures and to formulate a mitigation plan.

The <u>outcome</u> of this work is to allow for:

- maps identifying areas where additional mitigation measures must be applied or where the design of electricity power lines must be amended to avoid vulture collisions or electrocutions in the Stormberg and Cookhouse REDZs.
- mitigation measures are to be provided and costed. This work will be required to be undertaken in close consultation with relevant NGOs, Eskom and the wind and solar energy associations

### 2. MANDATORY INITIATION WORKSHOP

A mandatory one-day project initiation workshop will be held online week of 20 November 2023.

### 3. OPTIONAL SITE VISIT

The assessment will be conducted at a scoping and desktop level and ground truthing. It is, however, encouraged to undertake one or two day reconnaissance trips to any focus areas the proposed supplier is not adequately acquainted with. Travel and accommodation for the reconnaissance trips should be budgeted for by the proposed supplier.

#### 4. GIS

The SEA has a strong GIS focus as such suppliers mut have GIS capabilities and submit all final data in the required formats.

#### 5. DATA, REPORT SUBMISSION AND FORMATS

- An assessment report template that will be provided at a later stage will be used to standardise report formatting and guide the report layout;
- Reports must be submitted in English and in MS Word format;
- All maps included in the report must also be submitted as separate JPEGs;

### 6. ASSESSMENT

The avifauna assessment on vulture electrocution risks in the Stromberg and Cookhouse REDZs in the Eastern Cape, will be focused primarily on the interpretation of existing data and should be based on defensible and, if available, standardised and recognised planning methodologies.

The key deliverables and reporting requirements include:

- o A baseline description the two REDZs related to vultures;
- mapping of electrocution risk in the two REDZs;
- A description of the study methodology for the specific strategic issue and source of data/information;
- Report to contain an upfront summary of key findings and recommendations, including degreeof-certainty and gaps in knowledge/data;
- Assumptions, limitations, confidence estimates and the definition of issue scope and key terms;
- Submit sensitivity maps for both REDZs;
- Identification of key knowledge gaps that would either increase or decrease sensitivity in the areas significantly for further assessment;
- o Mitigation measures are to be provided and costed relating to the strategic issue;
- A conclusion (summary of findings) and discussion;
- Assist in addressing the stakeholder and expert comments on the vulture electrocution mapping and proposed mitigation measures and costing; and

- 4.2 The Party(ies) undertake(s) to ensure that all reasonable measures are taken to:
- 4.2.1 identify reasonably foreseeable internal and external risks to the Personal Information in its possession or under its control;
- 4.2.2 establish and maintain appropriate security safeguards against the identified risks;
- 4.2.3 regularly verify that the security safeguards are effectively implemented;
- 4.2.4 ensure that the security safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards;
- 4.2.5 provide immediate notification to the Responsible Party if a breach in information security or any other applicable security safeguard occurs; provide immediate notification to the Responsible Party where there are reasonable grounds to believe that

the Personal Information has been accessed or acquired by any unauthorised person;

- 4.2.6 remedy any breach of a security safeguard in the shortest reasonable time and provide the Responsible Party with the details of the breach and, if applicable, the reasonable measures implemented to address the security safeguard breach;
- 4.2.7 provide immediate notification to the Responsible Party where either party has, or reasonably suspects that, Personal Information has been processed outside of the purpose agreed to or consented to;
- 4.2.8 provide the Responsible Party, upon request, with all information of any nature whatsoever relating to the processing of the Personal Information for the purpose in terms of this Agreement and any applicable law; and
- 4.2.9 notify the CSIR, if lawful, of receipt of any request for access to Personal Information, in its possession and relating to the CSIR.
- 4.3 The CSIR reserves the right to inspect the Personal Information processing operations, as well as the technical and organisational information security measures employed by the contracting Party to ensure compliance with the provisions of clause 4.
- 4.4 The provisions of clause 4 shall survive the termination of this Agreement, regardless of cause, in perpetuity.

#### 5 Exclusions

- 5.1 The Receiving Party recognises that this agreement is not intended to restrict use or disclosure of any portion of the Disclosing Party's Confidential Information which:
- 5.1.1 is as at the Effective Date, or later, made known to the public or otherwise enters the public domain through no default by the Receiving Party of its obligations under this Agreement;
- 5.1.2 it can show was in its possession prior to the earliest disclosure by the Disclosing Party, as evidenced by written documents in its files;
- 5.1.3 is rightfully received by it from a third party having no obligation of confidentiality to the Disclosing Party;
- 5.1.4 is independently developed by the Receiving Party by a person(s) who did not have access to the Confidential Information of the Disclosing Party;

- 5.1.5 is disclosed by the Receiving Party after receipt of written permission from the Disclosing Party; or
- 5.1.6 it is requested or required by subpoena, court order, or similar process to disclose, provided that, in such an event, it will provide the Disclosing Party with prompt written notice of such request(s) so that the latter may seek an appropriate protective order and/or waive the Receiving Party's compliance with the provisions of this agreement.

### 6 Ownership and Provision of Infomration

- 6.1 The Disclosing Party shall retain ownership of all its Confidential Information as disclosed hereunder.
- 6.2 Nothing contained in this agreement or in any disclosures made hereunder shall create or imply, or be construed as to grant to the Receiving Party any license or other rights in or to the Confidential Information and/or any intellectual property rights attached thereto, or act as a waiver of any rights that the Disclosing Party may have to prevent infringement or misappropriation of any patents, patent applications, trademarks, copyright, trade secrets, know-how or other intellectual property rights owned or controlled by the Disclosing Party as at the Effective Date.
- 6.3 The Disclosing Party provides the Confidential Information "as is" and accordingly no disclosure thereof by it hereunder shall constitute any warranty, representation, assurance. guarantee or inducement by such Disclosing Party with respect to infringement of patents or other rights of third parties, nor is any warranty or representation as to the accuracy, completeness, or technical or scientific quality of any of the Disclosing Party's Confidential Information provided hereunder. (For the avoidance of doubt it is stated expressly that the Disclosing Party neither makes, nor have made, any representation or warranty as to the merchantability or fitness for a particular purpose of any Confidential Information disclosed hereunder).

### 7 Term of Obligation

7.1 The Parties' obligations concerning nondisclosure of Confidential Information contained in the above clauses shall commence on the Effective Date and shall continue for five (5) years from the date of each disclosure, unless otherwise agreed between the parties in writing, where after such obligations shall forthwith terminate.

- 8 No Violation
- 8.1 Each party represents that its compliance with the provisions of this agreement will not violate any duty which such party may have towards any third party, including obligations concerning the provision of services to others, confidentiality of information and assignment of inventions, ideas, patents or copyright.
- 9 Breach
- 9.1 It is acknowledged that the breach of this agreement by the Receiving Party would cause the Disclosing Party irreparable injury not compensable in monetary damages alone. Accordingly, in the event of a breach, or a threat of a breach, the Disclosing Party, in addition to its other remedies, is entitled to a restraining order, preliminary injunction or similar relief so as to specifically enforce the terms of this agreement or prevent, cure or reduce the adverse effects of the breach.

### 10 DOMICILIUM CITANDI ET EXECUTANDI

10.1 The Parties hereto respectively choose as their *domicilium citandi et executandi* for all purposes of, and in connection with this agreement, the physical addresses and contact details stated herein.

11 Notices

- 11.1 Any Notice to be given hereunder shall be given in writing and may be given either personally or may be sent by post or facsimile and addressed to the relevant party at its *domicilium citandi et executandi* address as chosen herein. Any notice given by post shall be deemed to have been served on the expiry of 7 (seven) working days after same is posted by recorded delivery post or air mail. Any notice delivered personally or sent by facsimile shall be deemed to have been served at the time of delivery or sending.
- 12 Governing Law and Jurisdiction
- 12.1 This agreement will be governed and construed by the laws of the Republic of © CSIR 2017 Version: July 2017

South Africa and the Parties hereby submit to the exclusive jurisdiction of the South African courts to hear any dispute arising therefrom which the Parties are unable to settle amicably.

### 13 General

- 13.1 This agreement comprises the entire agreement between the parties concerning the subject matter and supersedes all prior oral and written agreements between them.
- 13.2 No waiver, alteration or cancellation of any of the provisions of the Agreement shall be binding unless made in writing and signed by the party to be bound.
- 13.3 The parties hereby warrant that the officials signing this agreement have the power to do so on behalf of the parties.
- 13.4 No public announcement, such as a media release, or disclosure beyond those disclosures authorised for Confidential Information hereunder may be made by either party concerning this agreement without the prior written approval of the other party.
- 13.5 Neither party is, by virtue of this agreement, authorised to use the name, logo(s) or trademarks of the other in connection with any advertising, publicity, or promotional marketing materials or activities, or for any other purpose whatsoever, without the prior written consent of the other party. For purposes of this clause, it is also recognised that, under the provisions of section 15 (1) of the Merchandise Marks Act, Act No 17 of 1941 of the Republic of South Africa, the use of the abbreviation of the name of the Council for Scientific and Industrial Research. "WNNR" and CSIR, is prohibited in connection with any trade, business. profession or occupation or in connection with a trade mark, mark or trade description applied to goods, other than with the consent of the CSIR.
- 13.6 Both Parties shall remain free to use, in the normal course of its business, its general knowledge, skills and experience incurred before, during or after the discussions envisaged hereunder. (To this end, it is also recorded that nothing in this Agreement shall be construed as constituting an exclusive arrangement between the parties and both Parties shall remain free to explore

market opportunities in the Field, unless otherwise agreed to in writing in a subsequent agreement.)
